

Terms and Conditions

Please review the terms and conditions regarding this tour. The tour description provides certain rights which you should review prior to making your deposit

PRICES: Land tour is based on rates, tariffs and ground costs (Euro rate) in effect May 1, 2010 at the time of tour quotation. Possible land increase costs in effect at the time the tour operates are subject to change without notice.

TRANSFERS: Transport after arrival in Malta is covered. Those who fail to provide flight arrival information are responsible for their own transfers to the hotel.

HOTELS: The tour price is based on shared accommodation in twin-bedded room with private shower or bath. A limited number of single rooms are available at additional supplements. Tour participants without a roommate will have to pay the single rate. Mediterranean Seas, LLC reserves the right to substitute hotels of a similar category if necessary.

SEQUENCE OF TOUR: As specified in each itinerary, including the service of a local Maltese guide. Right is reserved to vary the sequence of sightseeing programs or to make substitutions if necessitated by circumstances beyond our control.

Baggage: One average size suitcase and one carry on bag is permitted with a personal item such as a camera bag or purse. Carry-on bag must fit the dimensions of 9" x 14" x 22". Baggage is at owner's risk at all times

INCLUDED IN PRICE OF BASIC STANDARD PROGRAM: Transfers with group to and from Malta airport and piers; shared double room; with three meals daily (except where noted in the tour description); English speaking guide, transportation and entrance fees to sites to be visited. Local taxes are included.

NOT INCLUDED Passport fees, phone calls; valet/laundry service; and other items of a strictly personal nature; baggage or insurance.

PASSPORTS: All tour members must have a valid passport. To apply for passports, contact <http://travel.state.gov/passport> or your local post office.

RESERVATIONS are secured upon payment of the non-refundable deposit in the amount of \$400 per person.

DEPOSIT AND FINAL PAYMENT: A deposit of \$400 per person is due upon confirmation, and full payment is required 40 days prior to departure. Final payment received between 39 and 25 days before the tour adds a late booking charge of \$50. Extraordinary mail charges required by late booking, changes, or late payments must be borne by the passenger. Mediterranean Seas, LLC does not agree to provide any services until full payment is received.

CANCELLATIONS and REFUNDS: Please make all cancellations in writing. Cancellations received more than 40 days prior to departure will receive the full refund less the \$400 deposit and hotel deposit fee. Cancellations received within 40 days of tour, the deposit and amount the hotel and ground operator withholds is non-refundable. [Trip cancellation insurance is highly recommended.](#)

AIR: The tours are quoted as land based only.

INSURANCE: Mediterranean Seas, LLC, is not responsible or liable for loss, damage, theft of luggage or personal belongings, personal

injury, accidents, illnesses or trip cancellation. For your protection we suggest that you purchase adequate insurance to cover these eventualities and cost of your tour. We recommend [Travellex Insurance.](#)

REFUNDS FOR WITHDRAWAL OR ABSENCES during the tour are granted subject to the following: If illness or serious emergency compels you to leave the tour, a refund for unused services will be granted upon presentation of written documentation within 30 days of completion of tour. Refunds for missing occasional meals or sightseeing are not granted.

GENERAL CONDITIONS AND RESPONSIBILITY: Mediterranean Seas, LLC and its Associated Companies agree to provide the itinerary described and this represents the entire agreement between the passenger and his agent, the travel agent, the tour host, and the tour operator. Mediterranean Seas, LLC reserves the right to change or withdraw the tour, in whole or in part at any time. In the event of rescheduling of the tour due to unforeseen circumstances, the cancellation and refund clause will apply.
